EDUCATION AND TRAINING

The project is further supported by GREGS which are green skills development based on a LEONARDO initiative targeting school leavers and long term unemployed. The Courses will be directed at landscape gardening at a Level 1-3 MQC for the Ditch areas. On the other hand a series of masonry conservation at a Level 1-3 MQC for the fortification works is going to be based on a course development project initially launched by Heritage Enterprise with MCAST named CEPE. These projects are being developed in collaboration with the Corradino Correctional facility, MCAST and the University of Malta.

ADAPTIVE REUSE AND TOURISM

The project at Corradino Naval Prisons is a prime example on the adaptive-reuse of military ‘critical’ historical sites. For this project the private SME A.S. Hibernians have been successful in developing a project based on a triple helix template. One section of project is being funded by EU through a programme for SMEs in the tourism sector.

The project considers the development of the East-Wing with a restoration programme into an Interpretation Centre.

The project envisages the restoration of the South-Wing and the reinstatement of the roof (19th Century) targeting Energy Efficiency and RES exploiting micro-climates.
